- a. Regional Forester Opening Remarks: Enjoying getting to know how USFS works with Tribes--she is newer to the region. Acknowledge that the lands of WI are the homelands of the Native American Nations originally and the work the Tribes have been protecting the landscape. MOU is to provide more effective coordination in the future. First-year of MOU implementation was challenging due to the pandemic.
- b. PowerPoint Presentation to go over 1st year of MOU
 - i. MOU between WTCAC Tribes, USFS, State Forestry; the impetus was from many years ago, the goal was to solidify the relationship and build it stronger.
 - ii. Return to MOU each year to assess functionality and improve when necessary
 - iii. 1st Year Accomplishments:
 - 1. Chequamegon-Nicolet culvert inventory for stream revitalization; coordinating training with WTCAC staff
 - 2. Risk Assessment Training in FY19; goal to provide more training
 - 3. Two internship positions set for the upcoming year
 - 4. Shared grant opportunity information
 - 5. Climate Change Adaptation menu for projects
 - 6. Training in 8/2019; WTCAC Forestry Subcommittee training: Oak Wilt Training.
 - 7. Pesticide applicator training offered in 2016 & 2018 for Tribes led by USFS, John Kyle. Training hosted by Menominee Nation.
 - 8. Looking into the future: continue to provide technical assistance/support for WTCAC meetings and committee meetings, relay financial support opportunities, support summer internship program, support for EAB web series,
 - 9. Other opportunities: Tribal forestry inventory partnerships, culvert/stream crossings design partnerships, TEK partnerships, technical training opportunities (pesticide/herbicide applicator training), engineering technical assistance,
 - iv. <u>Tina VanZile</u> thanked Gina for her kind words and can tell that the USFS is hearing us and is listening. We have so many good relationships with WTCAC and we are continuing to learn from

- v. Paul Koll thanked everyone from the USFS and acknowledged Mary Rasmussen's work on the MOU as well. Training and technical assistance opportunities are greatly appreciated. Acknowledged prior committee meetings and training that USFS helped with that were extremely helpful.
- vi. Carleen Yocum state and private forestry grant opportunities.

 State and Private Forestry will refresh the spreadsheet and send it out to WTCAC. We are anxious to help people submit competitive proposals so do not hesitate to reach out and request assistance.

 All USFS proposals are competitive and do have a match requirement and we realize that can be a challenge. Tina Van Zile said that Mole Lake will take her up on her offer. Currently, Mole Lake does not have a forester.
- vii. Chris Borden from NRCS expressed appreciation as well for this partnership with USFS and NRCS has also learned a lot from this partnership and there has been progress made with making projects more meaningful on forested lands. We appreciate all the effort behind this partnership.
- viii. Darla Lenz added that there are new faces on the National Forest side, and this is a relatively new MOU so she is excited about the opportunities this will bring. She sees lots of opportunities to engage and learn.
 - ix. Dan Cornelius asked if there is much discussion about individual treaty rights and being able to exercise those on Forest Lands. Kira responded that Mary Rasmussen's position was split in two between Kira Kaufman and Rita Mills at Hiawatha. Please reach out directly to any of the Forest Supervisors or Kira or Rita with specific questions about resources but a lot of work has been and is being done. Darla Lenz added that she would like to hear what the requests are to determine how to respond. They are working on several projects through consultation with Tribal governments.

 - vi. New Ruffed Grouse Management Plan in 2020, drummer funds, etc.

- Working with College of Menominee Nation to have a recording on what APHIS PPQ does to have hosted on the college's website as an alternative to usual in-person presentation
- 3. Agency published the final rule to deregulate EAB which goes into effect 1/14/21; 2-page fact sheet has been released about what this means along with press release; mostly will affect timber and firewood folks especially if they ship these products out of state--it should be easier now for them once federal rules are rescinded in January; https://www.aphis.usda.gov/aphis/newsroom/stakeholder-info/sa by date/sa-2020/sa-12/eab-approach
- ii. WS Bob Willging (District Supervisor for Northern Program)
 - The internship program was successful again this year even with the difficulties presented by the pandemic; there is more funding for another WTCAC summer student for this upcoming year
 - 2. There are 3-4 seasonal positions for Wildlife Technician positions; usually, 7 months that start in April and go to October; let Bob know if we know anyone who might be interested; field positions
 - 3. Another position open to cover wildlife complaints in the northern half of Wisconsin; unique to provide technical assistance over a 1-800 number; office position; based at district office in Rhinelander
 - 4. UW Stevens Point job event as well as an event with Fox Valley Tech where these positions will be recruited for; he says WTCAC internships could also be recruited here
 - 5. Working on coming up with something they can do online for with PPQ internships too
 - 6. Jessica requests that Bob send vacancy announcements to WTCAC to distribute to Tribes so they can distribute them to Tribal membership

i. College of Agriculture and Life Sciences (CALS) - Bill Barker

i. Continues teaching and research mission with a mix of virtual and in-person; anticipate spring semester will continue to be a mix as long as the pandemic doesn't worsen; receive significant budget cuts due to the pandemic and they are just starting to figure out how to deal with this budget cut

j. Dept. of Ag, Trade, and Consumer Protection (DATCP) - Brian Kuhn

- i. Issued a Gypsy Moth Press Release update on trapping and treatment programs this week; increases in populations across the state; 62% increase this year but last year as a historic low population, so this year is closer to "normal"; plan on more trapping next year and preliminary less treatment acreage for next year
- ii. ATCP 21 which is plant pest and quarantine language for the state is moving forward; scoping approved by the board; an example of change is to EAB due to federal change; might be asking for WTCAC member to participate in these change discussions
- iii. Hearing on Hemp on 12/10/20; did not get public input on the hearing; preamble and discussion posted on their website now; the summary is that they are continuing with 2014 Farm Bill approach which is much more flexible than the 2018 Farm Bill's approach
- iv. Tina VZ reports there will be 6 new tribal council members starting in January and they would like to know more about the hemp project; asks if they could set up a meeting with Brian Kuhn, and he says yes, he could, or Ashley Andre could help coordinate this meeting
- k. The US Forest Service (USFS) MOU discussion earlier on agenda
- 1. Intertribal Agriculture Council (IAC) Dan Cornelius
 - i. Wanted to follow-up on Bill's update; Dan has a partial appointment at the University of Wisconsin: this year he taught a first-year interest group class for incoming students, focus on drawing in native students (though not limited to them) to give them an opportunity to start the academic experience with a class that resonated more deeply and incorporated some of the foods that they have back home; they had full enrollment for these classes ad

- ii. A successful annual conference last week: over 1000 people registered; talked about implementation to 2018 Farm Bill and a caucus conversation on that and engaging Tribal Leaders, with another priority on inter-tribal partnerships and connections both on a production standpoint and with WTCAC
- iii. Working on planning an in-person event 8/15-8/17 for 2021 for Food Sovereignty Symposium and Festival at KBIC and Northern Michigan University; will have to see what happens with COVID and vaccines
- iv. Dan worked with Jerry about hosting the Tribal Food Safety event back in February and recently got follow-up materials, including video and documents; will be going into e-learning online curriculum for access
- v. Annual Conference and Food Summits are recorded and on this website:
- vi. Bill thanks Dan for his good work on campus
- vii. Dan shares more information about different corn strains; talks about grant and research partnership opportunities

Working on creating a series of fact sheets for 2021 for waters and native nations in Wisconsin; especially with the incident on Little St. Germain Lake about tribal members being threatened for exercising their treaty rights through spearing; he wants to put together some fact sheets working with WTCAC and GLIFWC (Dylan Jennings); this will be his focus after WI Water Week

u. Natural Resources Conservation Service (NRCS) Chris Borden

- i. Looks like the first EQIP sign-up was limited, so at this point, they anticipate a second sign-up period; so, let Chris know if there are any projects being brainstormed because there might be a sign-up in March
 - 1. Jeremy reports that 200 acres with storm damage were cleaned up well; worked with NRCS and BIA to do this; sad because it was an old forest with lots of nice white oak that blew down
- ii. Good time to talk about CSP (Conservation Stewardship Program), so reach out to Chris or Tribal Liaisons or Jonathan Pruitt
- iii. Reports that they enjoyed participating in GLITC's Annual Virtual Conference; want help to identify strategies to attract people to virtual "booths"
- iv. As soon as we are out of COVID NRCS is going to try to make sugarbush management work more supported

v. The Nature Conservancy (TNC) - Do Not Move Firewood - Leigh Greenwood

- i. She has funding from USDA APHIS to increase advertising budget for targeted area, includes WI/MN Great Lakes Region; would like WTCAC's advice on where advertisement could reach the most amount of people for moving EAB onto Tribal Lands
 - 1. we can send ideas to her at lgreenwood@tnc.org
 - 2. Tina suggests working with GLIFWC clerks; target people who attend pow-wows and bring firewood for campsites (reach out to Tribes directly and powwow websites, etc.)
 - 3. Recommendations for WI magazine and Outdoor News magazine, and tribal/GLIFWC newsletters
 - 4. Lacey mentions WTCAC Internships working on outreach too

 - 1. WROC leaf-off infrared for 2019 should be published soon; there is limited use though since it leaf-off; but good for seeing what is happening in streams; the previous year was 2015 data
 - 2. 2020 NAIP Imagery from USDA is was shot in 1-ft resolution with 4-5 bands; this will be published soon for the entire state
- viii. WWA wetland video update: Katie sent Chris an email wondering who the draft edit should be shared with, Pat P. asks for her to send it to him.
- ix. Staffing changes will impact service to Tribal Nations; Kent Pena (GIS) retired; Andy Hart (Forester) moved out west; Mary King (NW Area Engineer) retired; need to get information from Paul Johnson before he leaves after retiring
 - 1. Tom M. notes he can help pick up some of the engineering work with May retiring
- x. New positions will be advertised starting next week; it will likely be a direct hire so the process may be quicker and NRCS will have more control over it than they normally would through USAjobs.gov
 - 1. Jerry asks for them to send him information so he can get information out to the right folks quickly
 - 2. Might be more of an opportunity for Tribal members with a direct-hire process
 - 3. Chris recommends that people interested in applying should talk to NRCS staff about how best to format their application information; also having NRCS know who is interested could help with their head-hunting through the direct-hire process
