

April Stone: April Stone is a self-taught Ash basket weaver and member of the Bad River Band of Lake Superior Chippewa (Ojibwe). In 1998, she spent a full year watching a basket used daily, unaware of the intimate relationship that was being formed. After one year of this basket in use, the lashing around its rim broke. This natural material's strength moved her to the point of wanting to know all she could about the qualities and characteristics of the wood, what it could do, and how to weave with it. She then spent the following year raising babies and weaving one basket after another. One year later, she was asked to share her working knowledge with the community. Since then, she has been sharing her knowledge and teachings with tribes, folks, schools, colleges, youth
