#### 3. Wisconsin Wetlands Association - Katie Beilfuss

- a. WWA started collaborating with WTCAC two years ago on a series of videos on wetland work and conservation. They shared the first two videos today. Hoping that there will be more videos in the future.
  - i. Oneida wetland restoration video
  - ii. Oneida healthy lands video
  - iii. Would like to collaborate with more WI tribes and like to work with partners to develop an outreach plan for these videos.
  - iv. Production cost: approximately \$10K plus additional cost for staff time and management; funding came from multiple sources.
  - v. Pat adds that Katie, Tracey, and the production company (Cloud North Company) were great to work with, they made it easy.

# 4. COVID 19 Economic Impact Statements - Jacqueline, Brenda, Georgia, and Arlene

- a. Want to talk about a partnership with USDA-OPPE and IRS to get information out across the country about Economic Impact payments
  - i. IRS has opportunities and resources for citizens of the US.
    - 1. IRS will start accepting tax returns on February 12th; want to articulate how the EIS and how to claim any outstanding EIS; also, information on unemployment and how it needs to be claimed on tax returns.
      - a. IRS.gov has a lot of information about this.
    - 2. US citizens and resident aliens were eligible to receive EI payments; talked about income thresholds; even those who didn't file tax returns but has a SSN# were eligible; 1st round in March and 2nd round in December 2020
    - 3. Need to include information on EIP on line 30 of the tax return, notice 144 form for amount issued for 1st payment, notice 144B form issued for 2nd payment--need to include this on form 1040 or 1040SR but there is also a free file on the IRS.gov website that walks you through the process of filing.

### 5. ATCP 21 Plant Inspection and Pest Control Rule - Shahla Werner

- a. Powerpoint located in meeting folder on Google Drive
- b. Proposed Rule Changes there are 10 FTE plant specialists, 3 LTE that inspect different areas of the plant industry
- c. Invasive species are outcompeting our native species
- d. ATCP 21 includes plant protection rules related to Wis. Stat. 94 and sometimes connected to APHIS
- e. Proposed changes are: adding exterior quarantines for the spotted lanternfly, elongate hemlock scale, and balsam woolly adelgid; rescinding quarantines for PSB, EA, and TCD; and adding Alaska to the infested area for HWA and updating the host list for *P. remorum* 
  - i. The spotted lanternfly (SLF) is very fast-moving, has cost major damage to grapevines and vineyards out east; feeds on maple, roses, hops, and other ornamentals; might not be able to survive cold temperatures in northern 3rd of Wisconsin; proposing exterior boundary quarantine for WI for SLF; monitoring with traps and doing social outreach
  - ii. Hemlock Wooly Adelgid an aphid-like insect that sucks fluid from the base of hemlock needs; found on east and west coast (but there might be resistance in western hemlock that means they live through infestation); not found in WI yet; ONLY infests hemlocks
  - iii. Elongate Hemlock Scale sucks fluids from the underside of hemlock, spruce, and fir needles; certain pesticides don't control the pest at all; can combine with other stressors/pests that result in

- tree death; inspectors have intercepted this pest during inspections; want a specific quarantine for this pest at this time
- iv. Balsam Wooly Adelgid BWA has destroyed 95% of Fraser firs in GSMNP; can cause branch deformities and tree mortalities; want to add exterior quarantine for BWA
- v. *Phytophthora ramorum* leaf blight (Sudden Oak Death) causes oak mortality and leaf blight in 70 other plant genera; found once in WI at nursery but seemed to have successfully prevented infestation at that time in 2019;
- vi. Removal of EAB quarantine due to the extensive spread; Pine Shoot Beetle has not observed to cause major forest health impacts so quarantine will be lifted; expecting to lift Thousand Cankers Disease quarantine due to lack of predicted impacts
- f. WTCAC (Lacey) has been asked to be one of the organizations for the Ad-Hoc Advisory Council and act as a liaison back to its member Tribes (though not speak for them); Tribes can comment on ATCP 21 during comment periods but there will be no formal consultation

# **FSA**

- ARC/PLC
  - Deadline is March 15th and UW-Extension has again provided recommendations for producers.
- Dairy Margin Coverage Program
  - Information forthcoming regarding the DMC Supplemental Production History increase that was recently passed as part of the last stimulus bill.
- Quality Loss Adjustment Program
  - FSA is under way with signup for the QLA. This program is intended to cover quality losses, more than 5%, due to qualifying disaster events such as excessive moisture, flooding, and tornadoes, in calendar years 2018 and 2019. Payments will be based upon nutrient values for forage crops such as alfalfa, mixed forage, and corn silage. Payments for grain crops will be based upon verifiable documentation of grading factors. Producers will be required to submit documentation to prove nutrient

  - The FSA is accepting new or modified applications from January 19 through February 26, 2021 for the Coronavirus Food Assistance Program, to clarify this is not CFAP 3, just expanded eligibility for CFAP 2. Livestock by contract growers, pullets and turfgrass sod are now eligible for CFAP 2 payments. The specialty crop and livestock calculation for specialty crops now accounts for crop insurance indemnities and payments through the NAP and WHIP+. This more accurately represents what a producer would have marketed if not for a cause of loss.
- Conservation Reserve Program
  - General Signup 56
    - Started January 4<sup>th</sup> and goes until February 12<sup>th</sup>. Consists of prairie (introduced and native grass plantings; rare and declining habitat) and tree (hardwood, softwood, and wildlife habitat) practices. This signup required a substantial reduction to Wisconsin's Conservation Priority Area, as well as Water Quality and Wildlife Priority Zones. Along with Ownership and Cropland eligibility, General Signup offers must meet one of three eligibility criteria; be an expiring CRP, located in a CPA, or have an Erodibility Index score of 8 or greater. Offers are ranked and accepted nationwide according to their Environmental Benefits Index score.
  - Continuous and CREP Signup 55
    - Active through September 30th. These practices are focused more specifically on solving targeted resource needs and acceptance is based on having and solving a specific resource concern. These are the filter strips, scrapes, wetland restorations, riparian buffers, grass waterways, among others.
  - New contracts no longer receive C/S for management and not all practices require mid management moving forward. There is still cost share for practice establishment.
  - Forest Management Incentive
    - National Office recently announced the Forest Management Incentive for CRP to replace the Tree Thinning Incentive. This program will provide financial assistance to CRP participants wanting to do forest stand improvements. Practices will include CP3, CP3A, CP4D, CP11, and CP22. Contracts in the final two years will not be eligible. More information on this is forthcoming.
